Description

Today, there are two Jewish sections at the Central Cemetery, which was established in 1874. The Old Israelite Section near Gate 1 of the Central Cemetery, occupied from 1879, comprises around 52,200 gravesites in which around 100,000 people are buried. It is owned by the City of Vienna. In 2019, extensive clearing was carried out here to halt the further deterioration of the graves. The cemetery is kept unlocked and is open to the public.
