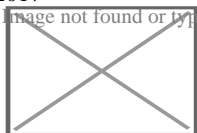

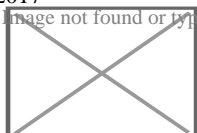


Legislation has been passed to redefine and expand the set of tasks assigned to the National Fund of the Republic of Austria for Victims of National Socialism.

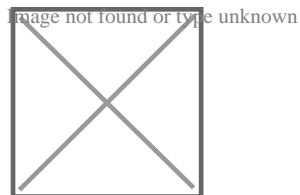

Ing. Robert Kanfer was the architect of the former Austrian national exhibition at Auschwitz.

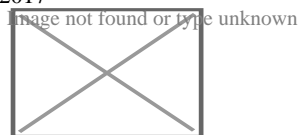

Restored Jewish cemetery in Stockerau transferred to the Municipality of Stockerau

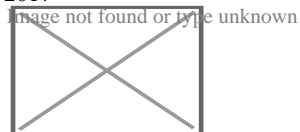
